

YUBA LAFCo NOTICE OF PROTEST HEARING

**A Reorganization of Linda Fire Protection District and City of Marysville Fire:
Reorganization consisting of 2,335.93 acres more or less (Project File LAFC-25-0003)**

NOTICE IS HEREBY GIVEN that the Yuba Local Agency Formation Commission (LAFCo) will hold a public protest hearing on Thursday, **October 30, 2025 at the Yuba County Government Center, in the Board of Supervisors Chambers, located at 915 8th Street, Marysville, California, to receive written protest against** the reorganization/annexation of approximately 2,335.93 acres of territory more or less, that will divest the provision of Fire/EMS services from the City of Marysville and annex the affected area into Linda Fire Protection District in order to provide Fire/EMS services to the incorporated area of the City of Marysville, within and along the exterior boundaries of the City of Marysville, in Yuba County. A map of the territory to be annexed into the Linda Fire Protection District for fire protection and emergency services is located on the LAFCo Website, www.yubalafco.org.

Owners of property and voters residing within the annexation territory may now file written protests against this proposal until the close of the protest hearing on October 30, 2025.

Proceedings for this proposal were initiated by both the City of Marysville, with the adoption of Resolution No. 2025-16 on June 18, 2025, and the Linda Fire Protection District, with the adoption of Resolution No. 2025-02 on June 12, 2025, to achieve greater efficiency in providing fire protection and emergency services in the best interests of the public. The Yuba Local Agency Formation Commission (LAFCo) approved the proposal with the adoption of Resolution No. 2025-06 on September 24, 2025, which will be effective upon recordation of the Certificate of Completion. The hearing will **BEGIN at 9:00 a.m. and END at 9:15 a.m. on October 30, 2025**, at the Yuba County Board of Supervisors Chambers in the Yuba County Government Center, located at 915 8th Street, Marysville, California.

To be counted, protests must be in writing with an original signature. They must be submitted before the close of the hearing, and they must be signed by owners of land within the reorganized territory and **(or)** by registered voters residing within the subject reorganized territory. A form is printed below for the convenience of anyone wishing to file a protest; it may be copied or filled in, detached, signed, and returned to the LAFCo office.

Protests may be mailed to Yuba LAFCo, 417 4th Street, Marysville, CA 95901 or delivered to the LAFCo Executive Officer or her designee at the protest hearing. Each protest must clearly state whether it is made by a landowner or a registered voter or submitted for both and must include the name and address of the person submitting it and original signature. Landowner protests must also include a street address or Assessor's parcel number identifying the location of the property in question. A registered voter's protest must show the voter's name and residence address as it appears on the affidavit of registration.

The value of protests received and not withdrawn before the hearing concludes will be determined within 30 days following the hearing in accordance with Government Code Section 57075. For more information, please call the LAFCo office at (530) 749-5467.
